

# Privacy Policy

This Privacy Policy governs the manner in which Ocqlar.com collects, uses, maintains and discloses information collected from users (each, a “User”) of the Ocqlar.com website (“Site”). This privacy policy applies to the Site and all products and services offered by Ocqlar.com.
